We follow European Parliament and Council Regulation (EU) No 1169/2011 when providing nutritional information. For food sold without its package, customer must be provided with information at every sale point.

Certainly, customer must receive information about the food names and allergenic or intolerable ingredients.

There is no need to bring up allergens if food name already refers to its content. Information on ingredients can be presented in several ways - using written, oral or both methods.
